



## File your Regular or Emergency Unemployment Compensation (EUC) Claim with no waiting!

Claimant wishing to file SEB or EUC claims must select “**Option 5**” after the language selection.

### **Types of Extensions**

Nevada currently has two different extensions available, Federal and State.

Nevada is paying the federal Emergency Unemployment Compensation (EUC) before State Extended Benefits (SEB). Claimants are only eligible for Federal or State Extended Benefits **if they have exhausted their regular unemployment claim and are not eligible for a new claim.**

## About EUC:

Your weekly benefit amount will be the same as your prior unemployment insurance claim. You may be entitled to receive up to 53 weeks or 208%, whichever is less, of the prior unemployment insurance claim.

Federal Emergency Unemployment Compensation (EUC) Benefit Table
Tier I -20 weeks or 80% of parent claim MBA, whichever is less
Tier II -13 weeks; Total 33 weeks or 130% of parent claim MBA, whichever is less
Tier IIa/III-14 weeks; Total 47 weeks or 184% of parent claim MBA, whichever is less
Tier IV-6 weeks; Total 53 weeks or 208% of parent claim MBA, whichever is less

### Eligibility Requirements:

You must have a benefit year that exhausted or expired on or after May 1, 2007, you must be currently unemployed, and have no eligibility for any other unemployment compensation. To determine if you meet the requirements of EUC, the claims examiner will review your eligibility to verify that you meet one of the following three conditions:

- a. **You must have one and a half times your high quarter in the base period of your prior claim; OR**
- b. **40 times your weekly benefit amount in the base period of your prior claim; OR**
- c. **20 weeks of full-time covered employment in the base period of your prior claim.**

### About State Extended Benefits (SEB)

The U.S. Department of Labor notified the state Employment Security Division that Nevada qualifies for State Extended Benefits because of a rising unemployment rate. This state extended benefits program is different from the federally funded Emergency Unemployment Compensation (EUC) program approved by Congress in 2008.

Although this program is effective the week of February 22, eligible claimants will continue on EUC until those benefits run out. At that time, they may be eligible for state extended benefits.

SEB pays up to 20 weeks of benefits. The first payable week was the week ending February 28, 2009. Claimants are notified by mail as they become potentially eligible for the SEB program and must file a new claim via telephone.

**Please be aware the State Extended Benefit Program is much more stringent than Extended Benefits Program because everyone, including hiring hall union members, must conduct a weekly work search and provide weekly documentation of having done so each week with the weekly claim.**
