**NOTICE OF INTENT TO ACT UPON A REGULATION
Notice of Hearing for the Adoption of a Regulation of the
Employment Security Division of the
Department of Employment, Training and Rehabilitation**

The Employment Security Division of the Department of Employment, Training and Rehabilitation (DETR) will hold a public hearing at 10:00 a.m., on Friday, January 15, 2010 in the Department of Employment, Training and Rehabilitation's 1st Floor Auditorium at 500 E. Third Street, Carson City, Nevada. The hearing is also available by videoconference at DETR's southern headquarters at 2800 E. St. Louis Avenue, Conference Room C, Las Vegas, Nevada. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of a regulation that pertains to Chapter 612 of the Nevada Administrative Code and Assembly Bill 338 that was passed during the 2008 Legislative Session.

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. Statement of need and purpose

The regulation is required to establish the in order to administer the program established pursuant to Assembly Bill 338 to provide grants to nonprofit entities to be used to make loans to veterans and senior citizens to start small businesses; establishes provisions for the administering and repayment of loans made under the program; and establishes criteria for the qualification of non-profit private entities to receive grants under the program.

2. How to obtain the revised text of regulation

3. Estimated Economic Effect

(a) Effect on businesses

The intent of this program is to foster the start up of small businesses primarily owned by senior citizens or Veterans.

(b) Effect on the public

The program benefits the public through increased economy activity in the State of Nevada by promoting business start ups. Small business provides employment opportunities for Nevada citizens, thus stimulating the economy.

4. Estimated cost

This program is funded by a .05% payroll assessment collected in conjunction with Unemployment Insurance taxes that fund Nevada's Career Enhancement program. No tax increase will be realized as the new program will be supported using existing resources.

5. Overlap or duplication of regulations

The proposed regulation does not overlap or duplicate any regulations of other state or local government agencies.

6. More stringent than federal regulations

The proposed regulation is not required pursuant to federal law, nor is there a federal regulation that regulates the same activity.

7. Summary of provisions more stringent than the federal regulations

Not applicable.

8. New or increased fee

This regulation does not establish a new fee or increase an existing fee.

Persons wishing to comment on the proposed action of the Department of Employment, Training and Rehabilitation, Employment Security Division, may appear at the scheduled public hearing or address their comments, data, views or arguments in written form to the Department of Employment, Training and Rehabilitation (DETR), Director's Office, 500 E. Third Street, Carson City, Nevada 89713. DETR must receive all written submissions on or before January 11, 2010. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, DETR may proceed immediately to action upon any written submissions.

A copy of this notice and the regulation to be amended will be on file at the Nevada State Library and Archives, 100 N. Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulation to be amended will be available at the Department of Employment, Training and Rehabilitation, Employment Security Division, 500 E. Third Street, Carson City, Nevada 89713, and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653 and on the Internet at <http://www.leg.state.nv.us>. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary. This does not apply to a public body subject to the Open Meeting Law.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption or incorporate therein its reason for overruling the consideration urged against its adoption.
