## Notice of Public Hearing to Solicit Comments on Nevada's Workforce Investment Act's Integrated State Plan

The Department of Employment, Training and Rehabilitation (DETR), will conduct a public hearing to discuss and elicit comments from the general public regarding potential changes to Nevada's Workforce Investment System as outlined in Nevada's draft Workforce Investment Act Integrated State Plan. Under the direction of Governor Brian Sandoval, Nevada will transition from the current Workforce Investment System to a structure that utilizes one statewide board of governance while retaining the two local workforce investment areas that are already in existence.

DETR is seeking input from the general public on potential changes to Nevada's statewide Workforce Investment System, which will be presented in Nevada's Integrated State Plan, along with any additional comments received during this public hearing, for approval by the Governor's Workforce Investment Board on June 14, 2012 at 1:00 p.m. Upon approval by the Governor's Workforce Investment Board, this plan will be submitted to the U.S. Department of Labor for final approval on July 1, 2012. This notice is provided in compliance with NRS 241.020. A copy of the agenda is attached.
